2.0 Source Protection Staff Update

Ms. Livingston and Mr. Brian Stratton presented a staff update. Mr. Stratton shared with the Committee the news of Randy Malcolm retiring from our Source Protection Committee. Brian recounted Randy's long-standing commitment and dedication to our Committee and thanked him for his years of service.

Tessa Di Iorio from the City of Ottawa was invited to speak and give an update to Committee members. Tessa summarized progress in 2023 and where they plan to focus their attention in 2024. Tessa also updated the Committee on the proposed shift in approach for the Lemieux Island Intake Improvement project due to difficulties getting approval from the Quebec Ministry. She shared that the search for an alternative location is underway.

Committee Member Bev Millar asked Tessa if the City could confirm the appropriate studies are done to ensure that the new location doesn't pull contaminants from downstream the intake due to wind. Tessa replied that she will inquire if this is being considered.

Marika Livingston shared with Committee that early engagement for the Section 36 update has commenced and she anticipates comments back from the Ministry in a few months.

Marika also shared that there is an upcoming Drinking Water Wise webinar on April 18, 2024 where they are joined by expert Dr Anna Majury, who will share how water quality can influence human health.

Ryan Hiemstra, Risk Management Inspector for the Mississippi-Rideau Source Protection Region shared that they completed follow-up site visits for any businesses who handle and store DNAPLs and gave an update.

Nigel Holgate, Program Analyst for the Ministry of Environment, Conservation and Parks introduced himself for the first time to the Committee. He is

assigned to the Mississippi-Rideau Source Protection Region to provide support, similar to the former Liaison role. He provided a verbal update.
